# The overall ECMMAN project

Funding Agency: The German Federal Ministry for the Environment, Nature Conservation, Building and Nuclear Safety (BMUB) supports this initiative on the basis of a decision adopted by the German Bundestag

General coordinator and leader: The Nature Conservancy (TNC)

**Project duration**: Four years (2013-2017) Funding: € 4 million

## **Objectives**

- Declare new marine managed areas (MMAs) and strengthen existing ones
- Build strong constituencies for sustainable livelihoods and ocean use
- Improve and update an Eastern Caribbean Decision Support System (EDCSS) that provides accessible decision making tools an incorporates current ecological, socio-economic, and climate change data
- Institute sustainable mechanisms to support the MMA network, including regional political commitments and actions, collaboration mechanisms on marine and coastal resources, and sustainable financing

## Involvement of UNEP-CEP, its SPAW-RAC and CaMPAM

The UNEP Caribbean Environment Programme (CEP) Secretariat of the SPAW Protocol of the Cartagena Convention, through its Regional Activity Center (SPAW-RAC) and the Caribbean Marine Protected Area Management Network and Forum (CaMPAM) is in charge of one component of the ECMMAN project: Strengthening the existing marine managed areas and supporting the establishment of new ones in the 6 participating countries. This is to be accomplished using one of CaMPAM major tools: the Small Grant Program.

## About the CaMPAM-ECMMAN Small Grant Program

Duration: Two and a half years (from January 2014 to the end of 2016)

## Funding: €1,176 million

The Small Grants program will apply the guiding principles of the Specially Protected Area and Wildlife (SPAW)

## **Objectives of the Small Grants**

To assist the 6 countries of the ECMMAN project (Antigua and Barbuda, Dominica, Grenada, Saint Kitts and Nevis, Saint Lucia, and Saint Vincent and the Grenadines) with financial resources and expertise to improve the capacities for creating new MMAs and better managing the existing ones, and in this way assist with national and international marine conservation commitments.

#### Protocol of the Cartagena Convention (administered by UNEP-CEP), and will benefit from the 15 years of CaMPAM experience, as well as of its technical and administrative resources and those of UNEP-CEP and the SPAW-RAC.

# **Criteria for selection**

- Projects led by non-governmental and governmental organizations in partnership both with capacity for implementation.
- Good record of project implementation by proponents.
- Projects with counterpart funding in-kind or in cash.
- Clear indication of sustainability of activities.


